

# PROTOCOL FOR MANAGING HEALTHY INTERNATIONAL CONFERENCES NEW UPDATES

EFFECTIVE DECEMBER 18, 2022

## WHAT YOU SHOULD KNOW BEFORE YOU GO

The Center for Disease Control and Prevention (CDC) recommends that everyone 5 years and older receive a primary series of a COVID-19 vaccine to be considered fully vaccinated.



### PRIMARY SERIES OF VACCINES

#### A PRIMARY SERIES CONSISTS OF:

a 2-dose series of an mRNA COVID-19 vaccine (Pfizer-BioNTech or Moderna), or a single-dose COVID-19 vaccine (Johnson & Johnson's Janssen vaccine) or its equivalent according to your country's requirements.

#### CONCERN FOR IMMUNITY

Out of an abundance of caution and to promote the safety of delegates attending national meetings of the Church of Our Lord Jesus Christ, Inc., **vaccination and up-to-date boosters are strongly recommended.**

1. Anyone **experiencing symptoms** should not attend the conference.
2. If you have **tested positive within five days of the conference**, please do not attend.
3. If you were **exposed to someone with confirmed COVID-19**, a high quality mask (N95 respirator or similar) should be worn when indoors for 10 days, as well as testing and monitoring for symptoms.



### CONFERENCE PROTOCOL

**MASKS are optional**, but are strongly recommended for all; especially those who are of advanced age or immunocompromised due to other comorbid conditions.

**SOCIAL DISTANCING:** Please practice when possible.

**HEALTHY HYGIENE:** Handwashing, hand sanitizing, keeping hands away from your face, is strongly recommended.

With respect to COOLJC's effort to protect its attendees from COVID-19, there are **NO EXCEPTIONS.**

**COOLJC is complying with the CDC and Hosting State's regulations.**

All delegates, attending the COOLJC International meetings, must register and adhere to this information at time of registration.
